

2025 Stallholders Terms & Conditions

Welcome to our first-ever Crafters & Creators Market at the Great Ocean Road Chocolaterie & Ice Creamery in Bellbrae!

To ensure a safe, fair and enjoyable day for all involved, please carefully read the following terms and conditions before applying.

Event Overview

- **Date & Location:** The market will be held on Saturday 8th November 2025, onsite at the Great Ocean Road Chocolaterie & Ice Creamery, Bellbrae, Victoria, outdoors only.
- **Market Hours:** 9:00am – 3:00pm
- **Bump-in:** From 8:00am on the day of the event.
- **Bump-out:** From 3:00pm, strictly no early pack-up.

Eligibility & Product Criteria

- Stalls must only feature products that are handmade, designed or created by the stallholder.
- Food stalls selling items for immediate consumption or products including chocolates, ice cream, desserts or hot food are not permitted. Other food stall options will be considered on application.
- Mass-produced or imported goods are not permitted.
- Changes to product range post-application require written approval.
- Preference will be given to stallholders located within the Geelong, Surf Coast & Bellarine region.

Stall Setup & Equipment

- All stalls are outdoor, and stallholders must supply:
 - Their own marquee (3x3m max), tables, chairs, display items
 - A payment method (e.g., Square, EFTPOS terminal). Free Wi-Fi will be available on-site.
- No power will be supplied.

- All marquees must be weighted securely with a minimum of 15kg per leg.
- Marquees must be weather appropriate and in good condition. Unsafe setups will be asked to pack down.

Public Liability Insurance

- Stallholders are required to have a current Public Liability Insurance policy with coverage of at least \$10 million.
- A valid certificate must be supplied with your application.

Weather Conditions & Cancellation

- As an outdoor market, the event will proceed rain, hail or shine, unless:
 - Unsafe conditions are forecast (e.g., high winds >50km/h, Extreme or Catastrophic fire danger, flooding).
- Any cancellation will be communicated via email and social media by 6:00am on market day.

Stallholder Conduct & Expectations

- Stallholders must:
 - Be ready to trade by 9:00am.
 - Remain open and staffed until 3:00pm.
 - Sell only products approved during application.
 - Be respectful to all staff, volunteers, customers, and fellow stallholders.
- Bullying, aggressive behaviour, or harassment will result in immediate removal and blacklisting from future events.

Waste & Environmental Responsibility

- The Chocolaterie is a plastic bag free venue.
- All stallholders must remove their own rubbish.
- Public bins are strictly for customer use only.

- Vehicle access for bump-in is allowed between 8:00am – 8:45am.
- All vehicles must be moved to designated parking areas before 9:00am.
- No vehicle movement is permitted onsite during market trading hours.

Application & Acceptance

- Stall applications will be reviewed based on:
 - Quality, creativity and presentation of goods
 - Fitting with our handmade and local ethos
- Successful applicants will be notified via email and required to confirm attendance by the specified due date.
